**INVITATION TO BID FOR PROCUREMENT OF SERVICE MOTOR  
VEHICLE FOR TESDA MIMAROPA REGIONAL OFFICE**

1. The *Technical Education and Skills Development Authority (TESDA) MIMAROPA Regional Office*, through the *2018 General Appropriations Act (GAA)* intends to apply the sum of *One Million Four Hundred Forty Two Thousand One Hundred Sixty Six Pesos and 67/100 Only (PhP1,442,166.67)* being the Approved Budget for the Contract (ABC) to payments under the contract for *Procurement of Service Motor Vehicle for TESDA MIMAROPA Regional Office/19-12-85*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Technical Education and Skills Development Authority (TESDA) MIMAROPA Regional Office* now invites bids for *One (1) Sports Utility Vehicle with an engine displacement not exceeding 2400cc Diesel*. Delivery of the Goods is required on *December 26, 2019*. Bidders should have completed, within *January to December 2018 and January to October 2019* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from *Technical Education and Skills Development Authority (TESDA) MIMAROPA Regional Office* and inspect the Bidding Documents at the address given below during office hours, *Monday to Friday 8:00 AM to 5:00 PM*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on *November 16, 2019 (Saturday) to December 9, 2019 (Monday) 12:00 Noon* from the address below *2<sup>nd</sup> floor Acob Building, Brgy. Lalud, Calapan City, Oriental Mindoro and upon payment*

*of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (PhP5,000.00).*

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. *The Technical Education and Skills Development Authority (TESDA) MIMAROPA Regional Office will hold a Pre-Bid Conference on November 25, 2019 (Monday) 1:00 PM to 5:00 PM at 2<sup>nd</sup> floor Acob Building, Brgy. Lalud, Calapan City, Oriental Mindoro, which shall be open to prospective bidders.*
7. *Bids must be duly received by the BAC Secretariat at the address below on or before December 9, 2019 (Monday) 12:00 Noon. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.*

*Bid opening shall be on December 9, 2019 (Monday) 1:00 PM at 2<sup>nd</sup> floor Acob Building, Brgy. Lalud, Calapan City, Oriental Mindoro. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.*

8. *The Technical Education and Skills Development Authority (TESDA) MIMAROPA Regional Office reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.*
