KNOW ALL MEN BY THESE PRESENTS:

This Agreement made and entered into this 27~~th~~ day of December, 2019 in Taguig City, Philippines by and between:

ISIDRO S. LAPEÑA, PhD., CSEE**, and hereinafter referred to as the **PROCURING ENTITY**;

and

SFM Sales Corporation - Mitsubishi Motors Lipa with address at KM 78.2 Pres. Laurel Highway, Lipa City, Batangas, represented in this instance by **JENIFER O. MEDINA** hereinafter referred to as the **SUPPLIER**;

WITNESSETH THAT

WHEREAS, the **PROCURING ENTITY** invites Bids for the **Procurement of Service Motor Vehicle for TESDA MIMAROPA REGIONAL OFFICE** and has accepted a Bid by the **SUPPLIER** for the supply of motor vehicle in the sum of One Million Four Hundred Forty-Two Thousand (Php 1,442,000.00) hereinafter called the "Contract Price"

NOW THE AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - a) The Bid Form and the Price Schedule submitted by the Bidder;
 - b) The Schedule of Requirements;
 - c) The General Conditions of Contract;
 - d) The Special Conditions of Contract; and
 - e) The Entity's Notification Award

In consideration of the payments to be made by the **PROCURING ENTITY** to the **SUPPLIER** as hereinafter mentioned, the **SUPPLIER** hereby covenants with the **PROCURING ENTITY** to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The **PROCURING ENTITY** hereby covenants to pay the **SUPPLIER** in consideration of the provision of motor vehicle and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the time and in the manner prescribed by the contract.


