Relative to the assessor's fee, the 36.4% increase which is equivalent to PhP 319.00 from the existing PhP 234.00 is limited to the qualifications under the Agriculture, Forestry and Fisheries, Health and Construction sectors.

Moreover, in determining the amount of assessment fees, a new direct cost item, which is the "Repair and Maintenance Cost" is now included. Repair and Maintenance (RM) costs" are fixed allowances provided for repair of the machine and shelter, which are usually estimated at 10% of the initial cost. It is a fixed cost incurred regardless of whether the machine is operated or not (Reference: Petingco.M. Amongo RM, et al. Fundamentals of Agricultural Engineering II - AENG 2 Manual, 2011). However, "Repair and Maintenance (RM) costs" were not applied to HEO qualifications because the machinery and equipment that will be used in the assessment will be rented (Reference: ACEL. Equipment Guidebook - Edition 25 Guiding Rates. 2014).

All ROs/POs shall ensure that the accredited Assessment Centers shall NOT charge any additional fees in the conduct of assessment.

This Circular takes effect as indicated and shall supersede any issuances inconsistent herewith.
